In continuation of our Admission notice dated- 12/06/2024, It is hereby informed to Student who has not appeared CUET for FYUG courses Arts & Commerce may take spot admission from **29th June to 1st July, 2024** in the college. They should bring the following documents.


- Self attested copy of Admit Card, Registration Card, Marksheet, Certificate of both 10th (H.S.L.C) and 12th (H.S).
- Bank Passbook of the candidate (Xerox).
- Aadhaar Card (xerox) / anyone from sl. no.-6.
- PWD certificate (if any).
- Caste Certificate (if any).
- NOC with registration card if already registered from Assam university.
- Gap certificate where applicable (from the last institution).
- Original Migration Certificate where applicable.
- Birth Certificate.

Special Note.- It is mandatory to create ABC Id Card prior to admission (to create the ABC id, visit Link- <https://www.abc.gov.in/>)

In pursuance of the Govt. of Assam OM vide letter No.- AHE.354/2021/8 dated 6/9/2021 students who are seeking admission under Fee waiver Scheme must note down the following points-

- Fee waiver scheme is applicable only for those students whose Parents Annual Income is below Rs. 2 Lakhs.
- If either of the parents (mother or father working as an employee in the state Govt./central Govt./Semi sate Govt./ Semi Central Govt. Undertaking, then such students will not be eligible to apply under the free waiver scheme.
- Income certificate having the current validity of one year by the local Revenue Circle Officer shall only be considered as proof of Income
- A deceleration/undertaking form the students that neither of the parents' employee in the state Govt./central Govt./Semi sate Govt./ Semi Central Govt., undertaking shall be required at the time of offline verification.
- The students have to plant a sapling at his/her college or his/her home and shall submit a photograph of the same during offline verification.
- For availing the fee waiver scheme, to prove that a student has a domicile of Assam, he/she must submit photocopy of any of the following documents during offline verification.
 - PRC
 - Voter ID
 - NRC of self or parents
 - Aadhaar Card of self
 - BPL card
 - Birth Certificate
 - Passport.
